### DISCUSSION

Leona Vigil read last year's top five ICIP projects. Mayor Jerah Cordova asked if there were any projects that needed to be removed from the list. Leona advised the Council that the Asset Management Plan does not qualify for capital improvement. She has a notice from Senator Baca; that item was removed (2019-002). La Luz and San Lorenzo are being self-funded that project was removed (2019-11). (2022-02) Valencia County Regional Dispatch Center and (2023-001) Comprehensive Plan were also removed. The dispatch center has already been built and plans are not eligible for capital outlay. Finally, the (2023-005) Third-Track infrastructure Improvements was removed; this project has been completed.

The top ten projects for the 2020-2024 ICIP were arranged as follows:

- 01 Reid Mae Pond and Drainage
- 02 Arsenic Removal (Cavco)
- 03 Senior Center Parking Lot to include land acquisition
- 04 Aragon Tank Rehabilitation
- 05 North Belen Interchange
- 06 SCADA system
- 07 Waste water Plant Improvements
- 08 Infrastructure Improvements (various streets)
- 09 Airport Sewer line Extension
- 10 Airport Parallel Taxiway
- 11 Airport Multi Use Building Phase I


The following projects were added to the end of the ICIP list (2024):
